

A SPECIAL NOTE TO CUSTOMERS ON BUDGET BILLING

The SRP Budget Billing program makes your monthly electric payment predictable by averaging your electricity costs from the hotter summer months with the milder months we enjoy in the Valley of the Sun. Every quarter, we review your Budget Billing amount to ensure you are paying neither too much nor too little toward your annual electric costs.

To determine what your new payment will be, we start by adding your monthly charges and have listed those below. To that total, we add what your account balance will be after we receive your April payment. The account balance can be a debit or a credit.

$$\$464.84 \div 184 = \$2.53$$

Next, we multiply the average daily cost by 31, which is the average number of days in a billing cycle.

$$\$2.53 \times 31 = \$78.43$$

Finally, this amount is rounded to the nearest \$1 increment.

$$\$78 = \text{new Budget Billing amount}$$

By calculating your Budget Billing amount this way, our goal is to bring your account to a zero balance each October. Your new Budget Billing amount of \$78 begins with your May bill. This amount is expected to be sufficient to cover the costs of your electricity through this October.

To determine what your new payment will be, we start by adding your monthly charges and have listed those below. To that total, we add what your account balance will be after we receive your January payment. The account balance can be a debit or a credit.




